Who is eligible to enter the Competition?: You are eligible to enter the Competition if you are a legal resident of Ireland and you were aged 18 years or over on the Competition Start Date. If you are an employee, operator, owner, director or officer of a Participating Retail Service Station, the Sponsor, the Administrator, anyone Professionally connected with the Competition, or you are a family member of or you live with one of them, you are **NOT** eligible to enter the Competition or to win prizes. This Competition is void outside Ireland.

**How to enter the Competition**: No purchase is necessary to enter the Competition. If you enter the Competition, you are agreeing to these Rules. You can enter the Competition in a number of ways:

## Retention of your personal data

Your personal data will be retained for no longer than is necessary for the purpose for which it was obtained by the Joint Controllers or as required or permitted for legal and legitimate business purposes. In general, the Joint Controllers (or their service providers on its behalf) will hold Competition entry information for a period of 60 days from the Competition end date when you opt-out, and winner details for a period of seven years, unless they are obliged to hold it for a longer period under law or applicable

You also have the right to request erasure of your personal data or to restrict processing (where applicable) in accordance with data protection law. We will update or delete your data in accordance with our obligations under the GDPR and Data Protection Act 2018.

Where you have consented to our use of your personal data (such as for direct marketing), you may at any time withdraw your consent. Where we are relying on our legitimate interests, you may object to any processing by us. Where applicable, you have the right to data portability of your personal data.

## Complaints
