

## TOP OIL YEAR OF FREE FUEL\* COMPETITION 2022 – OFFICIAL RULES – REVISED

The “Top Oil Year of Free Fuel\*” competition (the “Competition”) is offered by Tedcastles Oil Products Unlimited Company trading as Top Oil (“Sponsor”) and is being played at the Sponsor’s Participating Retail Service Stations. The Competition is administered by WSP International Limited (“Administrator”). The Sponsor, Participating Retail Service Stations and Administrator hereinafter will be referred to as the “Competition Entities”.

\*Year of Free Fuel is revised and limited to a maximum of €2,500.00. See Rule 4 below for full details.

**NO PURCHASE NECESSARY TO PLAY.** PARTICIPATION IN THE COMPETITION CONSTITUTES THE ENTRANT’S (“ENTRANT” OR “YOU” OR “YOUR”) FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE OFFICIAL RULES INCLUDING THE DECISIONS OF THE SPONSOR, WHICH ARE FINAL ON ALL MATTERS RELATING TO THE COMPETITION.

**GENERAL COMPETITION INFORMATION:** The Competition is being played at approximately two-hundred and twenty-five (225) participating Top Oil Retail Service Stations (“Participating Retail Service Stations”). To find a Participating Retail Service Station closest to you, visit <https://www.top.ie/competitions>. Go to [www.topoilwin.ie](http://www.topoilwin.ie) to enter to win prizes. See Rule 3 below for details on how you can enter and receive qualifying electronic entries into the competition (“entry or entries”) for a chance to win one of the prizes, or discount vouchers as described in Rule 4 below. You can obtain a free entry without making a purchase, also as described in see Rule 3 below. **1) COMPETITION DATES:** The Competition begins at 12:01 am IST on March 1, 2022 (the “Competition Start Date”) and is scheduled to end on December 31, 2022, at 11:59 pm IST (the “scheduled Competition End Date”). The period between the Competition Start Date and the scheduled Competition End Date is known as the “Competition Period”. Certain components of the Competition may end on different dates, as indicated elsewhere in these Official Rules.

**2) WHO CAN PLAY:** The Competition is open to all legal residents of Ireland, who have reached the age of eighteen (18) years as of Competition Start Date. Employees, operators, owners and directors of Participating Retail Service Stations (“Team Members”), as well as those persons that reside with any Team Member are **NOT** eligible to enter to win prizes in the Competition. Employees of the Sponsor and the Sponsor’s subsidiaries and affiliates as well as all General Managers, Chief Executive Officers and Board of Directors of any of the Participating Retail Service Stations (“Office Employees”) as well as those persons that reside with any Office Employee are also **NOT** eligible to enter to win prizes in the Competition. Employees of the Administrator or the Sponsor’s distributors, sales representatives, advertising and promotion agencies, and agents, participating prize sponsors, or any entity that the Sponsor contracts with, specific to this contest, as well as those persons that reside with such employees, are also **NOT** eligible to enter to win prizes in the Competition. Professional Drivers, who utilize a company issued Top Oil Fuel card (“Professional Fuel Card user”) and the company with whom they are employed (“Professional Fuel Card account holder”) are eligible to participate and win prizes as outlined in Rule 3, below.

**3) HOW TO ENTER:** You can earn entries for the Competition in any of the following ways:

**A) Upload your Receipt:** Throughout the Competition Period only, registered customers (see Rule 3B below) that spend a minimum of €15.00 (after tax) for fuel (diesel or petroleum only) or €15.00 (after tax) for eligible in-store purchases at any Participating Retail Service Station are invited, each month, to upload a picture of their valid cash register (“till”) receipts, for entries into the Grand Prize Drawings (See Rule 4). Each month, once you have successfully uploaded a valid till receipt, you will be given five (5) entries and be eligible to win that month’s Grand Prize Drawings for Free Fuel for a Year\*. You must upload a valid receipt during each month, or submit a valid No Purchase Entry, to be eligible to win any month’s Grand Prize. For Professional Fuel Card users and Professional Fuel Card account holders, there is a separate schedule of Grand Prizes available to be won, when you upload your receipt as noted above., and you will not be eligible for the other Grand Prize draws. See Rule 4 and Table 1 below, for full details on all prizes, eligible draw periods and drawing dates.

**Secondary Garth Brooks Concert Ticket Entries:** Following the schedule outlined in Rule 4, Table 1, the Sponsor will offer Secondary Garth Brooks Concert Ticket entries (see Rule 4, below) when customers upload their receipts. Each month throughout the Competition Period, once you have successfully uploaded a valid till receipt, you will be given your five (5) entries into the Grand Prize Drawings (see paragraph above). Your entries will also be eligible for the Garth Brooks Croke Park Concert Ticket prize draws in any relevant month as specified in Rule 4, Table 1 below. You must upload a valid receipt during each applicable month or submit a valid No Purchase Entry to be eligible to win any Secondary Garth Brooks Concert Ticket Prize. See Rule 4 and Table 1 below, for full details on all prizes, eligible draw periods and drawing dates.

**Secondary Pick Your Prize Entries:** Following the schedule outlined in Rule 4, Table 1, the Sponsor will offer Pick Your Prize entries (see Rule 4, below) when customers upload their receipts or submit a valid No Purchase Entry. Each month throughout the Competition Period, once you have successfully uploaded a valid till receipt or submitted a valid No Purchase Entry, you will be given

your five (5) entries into the Grand Prize Drawings (see paragraph above), and then you will be presented with a “Pick Your Prize” page and be presented with four (4) additional entries to be deposited in your choice of the four (4) Secondary Pick Your Prize drawings. You can “Pick Your Prize” and deposit your four (4) entries into any one or more of the Secondary Pick Your Prize drawings. You can continue to upload till receipts through August 31, 2022 and continue to choose into which Secondary Pick Your Prize drawings you wish to have your entries included. You must upload a valid receipt during each applicable month or drawing period or submit a valid No Purchase Entry to be eligible to win any Secondary Pick Your Prize. See Rule 4 and Table 1 below, for full details on all prizes, eligible draw periods and drawing dates.

**Additional Bonus Entries:** From time to time throughout the Competition Period, the Sponsor may also offer additional bonus entry offers (example: Double Grand Prize Entries) when customers upload their receipts during the specified offer period. Offers will be advertised and/or communicated by in-store posters, for opted-in registered customers (see Rule 3 B) below) and are time-limited.

**Purchases of Cigarettes, Tobacco products (including Vaping Products), Gift Cards, Vouchers and Certificates, Money Orders or Money Transfers, Postage Stamps, Tokens, Transit Passes, Lottery Tickets, Bill Payments and any items that are legally prohibited cannot be included in your purchase total. All till receipts must be uploaded before 11:59:59 IST on January 1, 2023. To be valid for any Grand Prize or Secondary Prize draw, a till receipt must include proof of purchase made during the Competition Period and be received within the month or prize period as outlined in Rule 4, Table 1.**

**B) Register for our Competition:** Visit [www.topoilwin.ie](http://www.topoilwin.ie) at any time during the Competition Period to register for the Competition and to receive one (1) registration entry. You must have completed the answer to the mathematical skill-testing question on entry into the Competition. All registration entries are valid for the Discount Voucher drawings (see Rule 4); however, to be eligible for the Grand Prize or Secondary Prize drawings for any particular month (see Rule 4), you must also have uploaded a minimum of one (1) qualifying till receipt (see Rule 3A above) during that month or have submitted a minimum of one (1) no purchase request) during that month (see 3E below). Follow the instructions on-screen to complete the electronic registration form, including but not limited to your name, valid email address and Participating Retail Service Station. Professional Fuel Card users must check the box on the registration form and complete the first six (6) digits of their Professional Fuel Card number to be entered into the drawings as noted above.

**C) Opt-in:** You will earn one (1) Opt-in Entry if you check the box on the online registration form indicating that you wish to receive information about the Competition and special offers from the Sponsor via email. You will earn one (1) additional Opt-in Entry if you check the box on the online registration form indicating that you wish to receive information about the Competition and special offers from the Sponsor via SMS text messages to your cell phone. All Opt-in Entries are valid for the Discount Voucher drawings (see Rule 4); however, to be eligible for any of the Grand Prize or Secondary drawings for any particular month (see Rule 4), you must also have uploaded a minimum of one (1) valid till receipt (see 3A above) or have submitted a minimum of one (1) no purchase request during that month (see 3E below). You can change your mind about receipt of special offers from the Sponsor at any time and opt-out– see Rule 7 below for full details.

**D) Social Media Bonus Codes:** Throughout the Competition Period, Sponsor may offer Bonus Codes on certain social media or advertising platforms including but not limited to Facebook and Instagram. Sponsor will post Bonus Codes on their social media pages that customers can enter at [www.topoilwin.ie](http://www.topoilwin.ie). You will receive one (1) Bonus Code Entry per Bonus Code entered. Bonus Codes can only be entered once. All Bonus Code Entries are valid for the Discount Voucher drawings for any particular month (see Rule 4); however, to be eligible for any of the Grand Prize or Secondary Pick Your Prize drawings, you must also have uploaded a minimum of one (1) qualifying till receipt (see 3A above) or have submitted a minimum of one (1) no purchase request for any particular month (see 3E below). The Competition is in no way sponsored, endorsed, administered by, or associated with Facebook or Instagram or any other social media platforms.

**E) No Purchase Entry:** Throughout the Competition Period, you can request a No Purchase entry. You will receive five (5) entries into the Grand Prize, Secondary Prize and the Discount Voucher drawings, for the month the No Purchase request was received (see Rule 4) without making a purchase or registering for the Competition. From July 1, through August 31, 2022, you will be given an additional four (4) Pick Your Prize No Purchase entries. You must clearly print your name, complete residential address, phone number, Participating Retail Service Station, your valid e-mail address and if applicable, the “Pick Your Prize” choice of which prize drawing(s) you wish to be entered into, all on a 3” x 5” card. **You will also be required to legibly print the following sentence and correctly complete the following skill-testing question: “My answer to this skill-testing question: Add 10 + 8, then divide the answer by 2 and then add 3 for a final answer of: \_\_\_.”** Mail in an envelope with proper postage to "Top Oil Win Free Fuel, P1, East Point Business Park, Dublin3, D03 C825". There is a limit of one (1) no purchase necessary request per person per day; and one (1) no purchase necessary request per outer mailing envelope. No mechanically reproduced or computer-generated requests allowed. All no purchase necessary entry requests must be received by December 31, 2022. Administrator will combine valid no purchase entries received with all other entries, prior to any drawings. You will be contacted only in the event that you are a winner. See Rule 7) Privacy for Sponsor’s policies on collection of data.

See Rule 4, Table 1 below for prizes and drawing dates. To enter online you must have at a minimum Internet Explorer 9, Chrome 25.0, Mozilla Firefox 30.00, Opera 16, or Safari 4.0. In the event of a dispute as to who submitted an online entry, the entry will be deemed to be submitted by the “Authorized Email Account Holder” of the email address provided by an Internet access provider,

online service provider or other organization (i.e. business, educational institution) that is responsible for assigning email addresses for the domain associated with the submitted email address.

All entries become the property of Sponsor and will not be returned. Competition Entities are NOT responsible for any lost, late, damaged, incomplete, illegible, misdirected, undeliverable or postage due mail; email, network, electronic, software, equipment, service, processing, accessibility or other errors, failures or issues; unauthorized access, tampering, hacking, theft or destruction; or other technical or human error related to the promotion, execution or administration of the Competition.

**4) PRIZES: Grand Prizes** - There will be ten (10) draws held (one per month during the Competition Period) to randomly award the **Grand Prize of Free Petrol/Diesel Fuel for a Year\***, following the schedule in Table 1 below. Each Grand Prize is valued at and limited to a maximum of €2,500.00. Petrol/Diesel Fuel prize, is awarded as a Top Oil Fuel Card totaling but not exceeding €2,500.00. Terms and conditions will apply to use of the Top Oil Fuel Cards; those terms and conditions will be made available to the Grand Prize winners or on request. You must upload a valid receipt or submit a no purchase request for any particular month to be eligible to win the Grand Prize for that month (See Rule 3).

**IMPORTANT NOTE: Effective August 12, 2022, the value of the Year of Free Fuel\* prize was increased from €2,000.00 to €2,500.00. All previously awarded Year for Free Fuel\* prize winners of €2,000.00 will be awarded the additional €500.00, following procedures as outlined in Rule 5, below.**

**Professional Fuel Card user and Professional Fuel Card account holder Grand Prizes** – For the Professional Fuel Card user and Professional Fuel Card account holders ONLY, there will be five (5) draws held to randomly award ten (10) prizes of a Top Oil Fuel Card totaling but not exceeding €2,000.00. For each drawing one (1) prize will be awarded to the eligible Professional Fuel Card user and one (1) prize awarded to the Professional Fuel Card user account holder for the Professional Fuel Card user. Terms and conditions will apply to use of the Top Oil Fuel Cards; those terms and conditions will be made available to the Grand Prize winners or on request. You must upload a valid receipt or submit a no purchase request to be eligible to win the Professional Fuel Card user prize (See Rule 3). Important: Professional Fuel Card user prize drawings are date specific, please see Table 1, below for full details.

**Secondary Prizes** – As stated in Rule 3A) above, once you have successfully uploaded your receipt online and earned your entries into the Grand Prize Drawing(s), you will also be entered into the Secondary Prize drawings. Important – Secondary Prize Drawings are date specific, please see Table 1, below for full details.

- i) **Garth Brooks Croke Park Concert Tickets for 2**, Approximate Retail Value (“ARV”) €200.00 per pair of tickets. Covers admission only for September 9 through 17, 2022 concert dates at Croke Park Stadium. See Rule 5 for additional details on this prize.
- ii) **Pick Your Prize - Tayto Park® Family Pass for 4**, ARV €380.00. Covers unlimited attractions plus discounts on food and beverages and discounted rates for special events. Terms and conditions apply. Full details at <https://taytopark.ie/visitor-information/family-membership>.
- iii) **Pick Your Prize - Irelandhotels.com Hotel Gift Card**, ARV €300.00. Valid at hundreds of hotels across Ireland. Terms and conditions apply. Full details at <https://www.irelandhotels.com/>.
- iv) **Pick Your Prize - One4All Gift Card**, ARV €300.00. Terms and conditions apply. Full details at <https://www.one4all.ie/>.
- v) **Pick Your Prize - Top Oil Home Heating Oil or Petrol/Diesel Fuel Gift Card** Pick Your Prize, is valued at, and limited to a maximum of €300.00. Home Heating Oil prize, if selected, is awarded as a credit applied to the winner’s account at their specified depot location totaling but not exceeding €300.00. If you do not have an account, one will be set up for you, prior to the awarding of the prize. Petrol/Diesel Fuel Gift Card will be awarded as six, fifty euro (6 x €50.00) Top Oil Fuel Vouchers. Terms and conditions will apply to use of the Top Oil Fuel Vouchers; those terms and conditions will be made available to the Grand Prize winners or on request.

There will be thirteen (13) draws held to award a total of forty-nine (49) Secondary Prizes following the schedule in Table 1 below.

For **Garth Brooks Croke Park Concert Tickets for 2**, during the prize periods only (as stated in Table 1 below), every time you upload a valid receipt (see Rule 3 A, above), you will be eligible to win the secondary prize drawings for the Garth Brooks Concert tickets. This includes where you are a Professional Fuel Card user or Professional Fuel Card account holder. For Professional Fuel Card users and Professional Fuel Card account holders only, there will be one (1) additional drawing for **Garth Brooks Croke Park Concert Tickets for 2** (See Table 1 for details).

For **Pick Your Prize - Tayto Park® Family Pass for 4, Irelandhotels.com Hotel Gift Card, One4All Gift Card, and Top Oil Home Heating Oil or Petrol/Diesel Fuel Gift Card** prizes only, every time you upload a receipt (see Rule 3 A, above) during the prize periods only (as stated in Table 1 below), you will be presented with a Pick Your Prize screen that will include four (4) additional entries to enter into your choice of these four (4) Secondary Prize drawings. You may include all 4 entries for any one prize or distribute your entries as you wish.

You must upload a valid receipt or submit a no purchase request for any particular month or prize period to be eligible to win the Grand Prize or Secondary Prizes for that month or prize period (See Rule 3A and 3E above). Entrants may only win one (1) Grand Prize or one (1) Secondary Prize during the Competition Period. If you have already been selected as a potential winner for any Grand Prize or Secondary Prize (see Rule 5), you will not be eligible to be a potential winner in any subsequent Secondary Prize drawings or the Grand Prize draw. Professional Fuel Card users are eligible to enter all of the Secondary Prize drawings. However, if a Professional Fuel Card user has already been selected as a potential winner for any Grand Prize or Secondary Prize (see Rule 5), you will not be eligible to be a potential winner in any subsequent Secondary Prize drawings or the Grand Prize draw.

Total value of all Grand Prize and all Secondary Prizes (including Professional Fuel Card user and Professional Fuel Card account holder prizes) is €59,120.00.

**Discount Vouchers** - There will be a total of twenty (20) draws held to award a total of two thousand (2,000) Top Oil non-transferrable discount vouchers following the schedule in Table 1 below. There will be one thousand (1,000) discount vouchers available valued at, and limited to, €15.00 off a minimum €15.00 purchase of petroleum or diesel fuel and one thousand (1,000) discount vouchers available valued at, and limited to, €10.00 off a minimum €10.00 purchase of petroleum or diesel fuel. Other Discount Voucher terms and conditions apply, see voucher for details. All entries are applicable for the Discount Voucher drawings. Limit four (4) Discount Vouchers per person. Professional Fuel Card users are eligible for the Discount Voucher drawings. Total value all Discount Vouchers €25,000.00.

**Important: Your entries accumulate throughout the promotion; however, you must upload a valid receipt each month to be included in that month’s specified Grand Prize or Secondary Prize Draws (see Rule 3A, above). If you do not upload a receipt in any given month, your entries carry forward to your next eligible draw.** Draws will be held at the offices of the Administrator and each draw will include all qualifying entries received as noted in Table 1. prior to each drawing. Official timeclock will be Administrator’s computers.

**5) NOTIFICATION AND REDEMPTION:** If you have been selected as a potential winner in any of the drawings described above, the Sponsor or Administrator will notify you via e-mail and/or phone. If the selected potential winner does not respond to the Sponsor’s or Administrator’s notification within fourteen (14) days of the Prize Draw and the Sponsor or Administrator has made three (3) separate contact attempts, the potential winner will be disqualified and a new potential winner may (at the Sponsor’s discretion) be drawn from among the eligible entries. As a condition of awarding any prize, the potential winner must have signed and returned, within seven (7) days of receipt, the Sponsor’s Statement of Compliance, Release, and Indemnity Agreement (“Release”) under which, among other matters, the potential winner confirms his/her compliance and eligibility with these Official Rules, completes current releases and indemnifies Competition Entities, and other certain parties. The potential winner must have correctly answered the mathematical skill-testing question before any Prize is awarded. If a potential winner refuses or fails to timely return the required documents, in accordance with these Official Rules, or is found to have violated the Official Rules of the Competition in any way or is deemed ineligible to receive a prize for any reason, or if any prize or prize notification from Sponsor or Administrator is returned as undeliverable, the potential winner will be disqualified and will be deemed to have forfeited the prize in question. If the potential winner is disqualified and forfeits the prize, the Sponsor may (at its discretion) hold a drawing to select an alternate prize winner from among the pool of remaining, eligible entries received.

**For Grand Prizes and Secondary Prizes:** Prizes will be shipped to, or made available at, the Participating Retail Service Station closest to the winner’s valid disclosed address by prepaid delivery. The Sponsor’s representative will contact the winner by telephone and/or mail to make arrangements for the winner to pick the prize up at the Participating Retail Service Station.
